# PRESIDENT'S REPORT

- Before we begin, let us observe a moment of silence in honour of the 215 children of the Kamloops Indian Residential School. Thank you.
- As we approach our 20<sup>th</sup> season, we'd like to acknowledge the VMHA Life Members present; some still actively participating in VMHA activities such as the annual general meeting, Al Boyd Bursary selection committee, and our Christmas tournament.
- Thanks also to our volunteers, coaches and team administrators who kept our players safe and engaged to the end of the season.
- The recent VMHA Membership Engagement Survey provided the board valuable information for the coming season; changes have already been made to our communication strategy and volunteer management system and increased player development will be a priority for the new board.
- Decreasing PHO restrictions should allow us to use the VMHA Training Centre for regular, small group programming this summer and fall.
- Ice allocation will remain tight for the coming season. Summer programming is currently in the works, with activities beginning mid to late August, and we anticipate a return to game play this fall.
- We would like to recognize an extraordinary volunteer this year. Maria Johnston began volunteering with VMHA in 2004 and has been our Referee Assignor since 2010. In addition to the VMHA Board, Maria also served as a PCAHA League Manager. Thank you, Maria, for your years of service, congratulations on becoming our newest Life Member.

## CONSIDERATION OF THE FINANCIAL STATEMENTS

#### 2020-2021 Season

- Decreased revenue (approximately \$160k) resulting from the loss of major fundraising initiatives (tournament/hockey pool) due to Covid. Slight decrease in registration numbers as well.
- Expenses were closely managed. Most significant expense remains ice rental. VMHA Training Centre costs approximately \$60k per year to operate.
- Season deficit (\$78k) covered by cash reserves on hand.

## 2021-2022 Season

- Evaluation of cost per player and division to ensure association operates on a break-even basis.
- Likely to see increase in registration fees as a result.
- Budget prepared in anticipation of a "normal" season beginning in September. Currently 427 players registered (48 more than this time last year). Plan to run tournament and hockey pool. Will continue to closely monitor expenses.

Question from Andrew James: Hockey Pool fundraiser is hard to follow. Is there a way to make it more engaging/easier to follow your teams?

Answer from Mike Coderre: Hockey Pool is onerous to operate but is our single largest fundraising event.
